ST. PAUL'S EPISCOPAL CHURCH Vestry Meeting – Zoom March 15, 2021

Call to order: The meeting was called to order at 6:35 pm by K. Lewis+. Devotions were given by S.

LeDuc.

Approval of the Agenda:

Added to the Agenda - In Person Worship - moved it first on the Agenda.

Remove from the Agenda - Mission & Values Interviews

M. Schulte moved to accept the revised agenda. Support by D. Parks. Motion carried.

In Person Worship: Bishop Perry and the Bishops of Michigan unexpectedly gave notice this afternoon that the Episcopal Churches of the State of Michigan can return to in person worship on Palm Sunday. The Bishops of Michigan have previously used guidelines for reentry based on covid19 cases current in Michigan counties. It appears the previous criteria has been revised. There is a concern about the current number of Michigan counties who have elevated cases of covid 19. There is much preparation needed for in person worship. K. Lewis+ stated that time and current plans in place will not allow St. Paul's to go back to in person worship for Holy Week. Easter Sunday is possible as the first in person worship service. Two services could be scheduled: 8:30 & 10:30 or 9 and 11. Discussion explored plans pro and con for the return to in person worship on Easter. Plans should include in person or the possible of cancelation by the Bishops. A rehearsal for Easter would be held on the 27th. The Vestry was asked to review the Logistic Task Force plan of 2020. B. Merriman will communicate any needed revisions to the 2020 plan. Communications Task Force will meet with Logistics for pre planning and any revisions. Communication to the congregation needs to be soon as Bishop Perry has publically announced in person worship. Registration for attendance should soon begin. The Jot Form as prepared in 2020 is still current. There will be a need to assign who will fulfill various roles / duties to assist with the service. A sexton will not be available for cleaning between the Easter services. St. Paul's occupancy is 300. 25% is 75 attendees. The percentage of attendance has not been finalized. It is important to communicate to the congregation the differences in worship in advance of attendance. Masks, social distancing, no wine, bread only, no congregational singing, and no sharing the peace are the main differences. A video to define how things will be different was suggested. The Sunday after Easter there will be only one service in the Sanctuary. On line services will continue when there are in person services. There are parishioners who would be very upset if St. Paul's does not return to in person services since the Bishops have granted permission for in person worship. It was pointed out that being at St. Paul's is probably safer than other public places like grocery stores or other public venues.

Consensus was reached by individual survey to have Easter as the first in person worship service with two services at 9 and 11 am. Office hours are to be determined. Small groups can now meet at the church.

The guests left the meeting.
